**CHANGE IN NOMINATIONS DATE AND THE DATE VOTER REGISTRATION CLOSES FOR THE
UPCOMING MOUNT AIRY 2012 ELECTION.**

A CITIZENS' MEETING WILL BE HELD FOR THE PURPOSE OF ACCEPTING NOMINATIONS OF CANDIDATES FOR THREE COUNCIL POSITIONS FOR THE TOWN OF MOUNT AIRY ON FEBRUARY 13, 2012 AT 7:00 P.M. AT THE MOUNT AIRY TOWN HALL, 110 SOUTH MAIN STREET, COUNCIL ROOM, MOUNT AIRY, MARYLAND. ALL NOMINEES SHALL BE NOMINATED WITH THEIR WRITTEN CONSENT.

PLEASE NOTE THAT FOR THE ELECTION YEARS OF 2012 AND 2014 NOMINATIONS WILL BE HELD ONE MONTH EARLIER THAN IN THE PAST. THE LAST DAY TO REGISTER TO VOTE IN THE 2012 MOUNT AIRY TOWN ELECTION WILL BE ON MARCH 13, 2012 AT 5:00 P.M., APPROXIMATELY ONE MONTH EARLIER THAN IN THE PAST.

IF YOU CURRENTLY LIVE WITHIN THE MOUNT AIRY TOWN LIMITS AND ARE REGISTERED WITH THE FREDERICK OR CARROLL COUNTY ELECTION BOARD YOU ARE AUTOMATICALLY REGISTERED TO VOTE IN THE TOWN OF MOUNT AIRY ELECTIONS.

THE REASON THE NOMINATIONS AND REGISTRATION DATES WILL BE CHANGED FOR THE 2012 AND 2014 ELECTIONS IS DUE TO THE DATE CHANGE OF THE PRESIDENTIAL AND GUBERNATORIAL PRIMARY ELECTIONS WITH REGARDS TO THE TOWN WORKING WITH THE COUNTY BOARD OF ELECTIONS.
