

**THE TOWN OF MOUNT AIRY  
ORDINANCE NO. 2021-9**

AN ORDINANCE TO AMEND ORDINANCE 2020-13, WHICH ADOPTED AND APPROVED THE BUDGET FOR THE TOWN OF MOUNT AIRY FOR FISCAL YEAR 2020-2021.

FOR THE PURPOSE OF AMENDING THE BUDGET BY REDUCING THE GENERAL FUND CAPITAL BUDGET BY \$820,000 FOR THE RAILS TO TRAILS - WEST OF MAIN STREET PROJECT.

WHEREAS, a land purchase for the Rails to Trails – West of Main Street Project was included in the budget for Fiscal Year 2020-2021; and

WHEREAS, the land purchase did not move forward in the time frame that was expected, and only minimal expenses were incurred; and

WHEREAS, an effort is made to maintain an up-to-date budget plan that best reflects current and ongoing projects based on the projects actual progress; and

WHEREAS, from time to time the Town Council wishes to adjust the budget for large projects that did not progress as planned; and

WHEREAS, the Town Council of Mount Airy Adopted Ordinance 2020-13 adopting the Budget for Fiscal Year 2020-2021 for the Town of Mount Airy on June 1, 2020; and

WHEREAS, the Town Council wishes to amend Ordinance 2020-13 as follows:

NOW THEREFORE, BE IT RESOLVED that the Town of Mount Airy Budget for Fiscal Year 2020-2021 be, and hereby is, amended to reduce the General Fund Capital Project for Rails to Trails – West of Main Street by \$820,000, along with \$820,000 in Grant funding; and that all other provisions of Ordinance 2020-13 shall remain unchanged and as is.
